January 8: Title VII meeting held in Red Cliff. Please see attached meeting minutes.

April 8,9 & 29: Staff attended an RTI training on Universal Math. This is designed at looking at the universal level of instruction aligned with the common core math standards. Staff will have the opportunity to analyze their current instruction and make some decisions at the Tier I level. In the fall, staff also attended the RTI training for Universal Reading.

April 11, 12: WIEA convention and our district Pow Wow took place. This was a wonderful event to attend. Close to 300 people were in attendance for this event. A big thank you to Dr. Jim Pete and Carmen VanderVenter for your help organizing this.

April 24: I will be attending an RTI training with Dr. Aslyn at CESA 12 for RTI coaching and implementation process. This is a consortium with 10 other districts. The goal of this consortium is to increase the capacity at the building level to implement Educator Effectiveness by developing professional development and collaboration between participating districts.

Curriculum: I will continue to work with our staff on updating curriculum work aligned to the state standards. Next year's focus will be developing Outcomes and Benchmarks for our English Language Arts following a similar process for the math curriculum that was developed and completed this year.
