## **Academic Achievement:**

Virtual Academic & Awards/Scholarship night will be held June 2nd, 6 p.m., via Zoom. Shellie is working with Keeley Karl on producing a slide show; Dan Livingston will get information from outside scholarship donors.

### **Supportive Climate:**

PBIS (Positive Behavior Interventions & Supports) training and survey page was updated by the state to reflect current coordinator and coaches. PBIS consultant will be working with team to help them develop a better understanding of their roles, especially as TSS & RtI begin merging to have a well-developed plan that meets many objectives.

Met with Progress North program recruiter to collaborate on getting student involvement with grassroots program. Focus is Indiginous Youth and getting their voices heard.

Yard signs ordered & will be delivered to Class of 2020 and Class of 2024. Diplomas will be personally delivered on the afternoon on June 5th.

### **Effective Communication:**

Weekly meetings continue to be held on Tuesdays with Middle School Staff and Thursdays with High School Staff. All agendas and minutes are available in a shared drive. It is very effective in regards to student engagement, sharing of ideas, and distributing the work load of contacting families so families are overloaded with every single teacher calling them.

Gathered input from staff for Student Handbook updates/changes.

Alt. Ed. committee chose four candidates for Middle School 20-21 program.

Contacted regional and state contacts to help us make local decisions concerning GEDO#2 graduation requirements due to closure of testing sides/COVID-19 related.

#### Use of Data & Resources:

Still working on arranging 2020-2021 schedule to meet student needs, especially pertaining to Foreign Language and family requests. Ironically, all of our hard work to get higher numbers in classes appears to be backfiring on us due to new health suggestions of ten or less students per class due to COVID-19. Dan Livingston, Anne Sullivan, and I will continue to generate what is needed most.

Four teachers (Business, Ag, FACE, Tech Ed) working with Randi Johnson and me to develop 20-21 plans for Carl Perkins. Jim Lee worked with group to share state updates and requirements. Team focusing on getting State Approved Industry Recognized Credentials (IRC).

Policy change due to 7 period day and graduation requirements being developed for Class of 2023 and beyond.

Based on data and guidance from the State of Wisconsin Health Department the graduation ceremony will be virtual. The virtual ceremony will be held June 6th.

# **Attendance:**
