Two words for this last month of planning: LEVEL TWO!! My staff and I have been diligently working to have answers to any possible question of how we will implement Level II instruction while also keeping staff, students, and our community safe. Unbelievable amount of team work, time, sweat and tears have been devoted to Level II.

### Academic Achievement:

Classroom observations occurred the three weeks prior to winter break. A variety of technology resources are in use by staff. It was amazing to see the variety used to meet different student needs.

Planning has begun for March 9th ACT testing and student prep. Afternoon periods the last week of February will be dedicated to test preparation with high school teaching staff. Saturday, February 27th, will be a practice assessment date.

### Supportive Climate:

Working with a team to find supports for a new ESL student. An interpreter has been found and will meet with high school teachers to help plan for student instruction and engagement.

### Effective Communication:

Course handbook updates have been made in collaboration with high school staff and guidance counselor.

### Use of Data & Resources:

Instruction Committee has been pulling all data together to create workable cohorts for Level II instruction. WISEDash Local training with entire administration team was held with new company representative.

### Attendance:

Staff continue to document attempts being made to reach a handful of students that are continuing to struggle with online attendance and engagement. Dean of Student involved to make follow-up contact. Truancy letters and citations continue to be sent out. A meeting was held with Red Cliff judicial members to review truancy policy and procedures. Dean of Students is working with Boys and Girls Club to find tutoring support.
