COVID/COVID Response

- Transition to fall
 - Met with district health partners, Red Cliff Community Health Center, Ashland County Health, Bayfield County Health (via email correspondence), District nurses, Jackie Noha, Angela Berg, and District Covid Response Coordinator to assess current uptick in COVID positive cases and how this might impact the start of the academic school year. Their strong recommendations are as follows:
 - universal masking for students and staff, while on the bus and indoors, regardless of vaccination status
 - no masks needed for outdoor activities
 - seating charts for bus and cafeteria
 - touch point cleaning and sanitizing
 - No spectators at athletic events for the month of September
 - No visitors to district schools for the month of September
 - reinstate weekly, mandatory (per district policy) staff COVID testing, effective Monday, Aug 23, 2021.
 - as much as is possible, student social distancing to 3'
 - as much as is possible, staff social distancing to 6'
 - kindergarten and first grade will eat meals in their classrooms
 - suspend high school students' open campus for month of September
 - CAT will practice a drill during staff in-service week
