Supportive Climate:

Effective Communication:

Perkins V End-of-Year Report was completed and submitted to CESA 12 for state reporting. Career Pathways CTE teachers who helped contribute to this report were D. Doering and C. Smith.

Use of Data & Resources:

The hybrid and virtual learning in 2020-2021 caused a low number (less than 20) to participate in the state and federal assessments. DPI required our district to report data via an alternate accountability process. Alternate Accountability schools may use local data and indicators of their choice to gauge student progress. Schools that have multiple years of data may choose to measure progress from fall to spring, or from the prior school year to the current school year. We used STAR data only from 2020-2021 to rate ourselves in both math and reading.

Schools indicate if performance is improving/maintaining or declining based on the measures chosen. This results in a rating of either Alternate Rating - Satisfactory Progress or Alternate Rating - Needs Improvement (if the school's progress is declining). Our district fell in the latter.

Student Learning Objectives (SLO) and Professional Practice Goals (PPG) have begun with surveys distributed by staff; analyzed; and goals set for students and staff. Effectiveness Project (EP) is the yearly ongoing evaluation system set up for teachers, administrators, and specialists.

Attendance:

Attendance has dropped in the last thirty days. Graph attached. Middle school currently has 89.23% year-to-date attendance. High school has 88.09% attendance rate. The attendance trend overall has dropped for the MS/HS combined with an all-time low of 88.7%. Graph attached to show downward trend.
