Covid/Covid Response

- Collaboration and weekly meetings with Red Cliff Tribal Council, Red Cliff Community Health Center, Bayfield County Health and Ashland County Health continues.
 - discussion of adjustments to 14 day quarantine
 - not recommended from Red Cliff Community Health
 - not recommended from Bayfield County Health
 - no science to back up adjusting current quarantine duration
 - COVID vaccination clinic December 14 & 15 for ages 5 years old and up, at Legendary Waters Convention Center. RCCHC will share details with us as soon as times are determined.
