Dean of Curriculum and Instruction Monthly Report

Date: October 14, 2022

- Cathy Smith and I will be attending a Financial Literacy conference on October 22nd in Green Bay. Financial Literacy is now required for graduation and the conference will provide us with curriculum and instruction support.
- I have organized a group of four staff members to participate in the career readiness community of practice conference through the DPI. The conference is free and we have been awarded two \$1000 stipends, yeah!!! The stipends will cover time spent developing a career readiness curriculum. We all came out of the first meeting with some amazing ideas, and are excited to start working on action plans. Stay tuned for more information in the coming months.
- I attended the first session of the Leadership and Coaching for Systems Change PD and am excited about how I can use what I am learning to build an effective coaching program here at Bayfield Schools. It will be valuable information for the PBIS/RtI team as well.
- The ELA Curriculum Review team met for the first time. I have ordered sample curricula from three publishers so far and will continue to make contact with others. ELA will be purchasing a new curriculum in the Spring for K-12.
- All other curriculum teams have met or will be meeting in October. One of my main goals is to find a curriculum that has been developed and house it in one central location.
- The MAP testing window was extended to Friday, October 14 th . There were still quite a few students who needed to finish the exams. The teachers did an amazing job administering the exam, I was really impressed. The school-wide data is attached to this report.
