Pupil Services

School Counselors - *Strategic Priority - Student Success*

- Junior conferencing focus will be the focus of Karla Vinci's SLO with her PPG focusing on ACP programming and structure.
- Schedules for student in the ID program were not accurate and needed to be revised to better allow for long-term sub, Travis Swanson, to provide instruction.
- Dan Livingston reports that the new elementary counseling curriculum is working well. Dan, Stephanie Lewis, and Mike Peterson discussed the potential of incorporating a service learning component to the school counseling instruction, partnered with the classroom teachers.
- B.e.s.t. Screener results - Mike will determine how he would like Dan to work with teachers to go over results, possibly in PLCs.

Pupil Services Teams - *Strategic Priority - Student & Staff Health and Wellbeing*

- The elementary pupil services team is meeting every other week and is currently discussing interventions for eight students of concern.
- The middle & high school pupil services team is meeting every other week and is currently discussing interventions for twelve students of concern.

School-Based Mental Health Grant

- Building the Heart of Successful Schools Conference, December 7 & 8. This conference was attended by Karl Wallin, middle school teacher; Melinda Suelflow, MS/HS FACE teacher; Karla Vinci, school counselor; Stephanie Lewis, DSE/Pupil Services; Muskadee Montano, home-school coordinator/tribal liaison (virtual attendance); and Johanna Wilson, Project LAUNCH Director/Bayfield school board member (virtual attendance.) The group plans to meet in January to debrief and share out any take-aways/suggestions to the district administration.

- On December 1, 2022, an informational zoom meeting was held for parents of 10th graders to learn more about the teen Mental Health First Aid curriculum that will be taught by Tracy Henegar, Senior Outreach Specialist Human Development & Relationships Educator, Bayfield & Douglas Counties, in health class starting in January 2023.

Human Resources - *Strategic Priority - District Excellence*

- Opening for a special education teacher of Intellectual Disabilities continues to be posted for the 2023-2024 school year.

Special Education - *Strategic Priority - Student Success & District Excellence*

- Bayfield School District is scheduled to participate in the Indicator 8-Family Engagement Survey. A training session is scheduled December 13, 2022, with the survey window open from mid-January through June 30, 2023.
- "The Indicator 8 Family Engagement Survey is one of Wisconsin's [State Performance Plan \(SPP\) improvement indicators](#). Indicator 8 identifies the **percent of parents with a child receiving special education services who report that schools facilitated parent involvement as a means of improving services and results for children with disabilities**. In Wisconsin, Indicator 8 is a cyclical indicator measured by a family engagement survey that local education agencies (e.g. school districts) must send once every five years to every parent in their district whose child is receiving special education services ages 3 through 17."
- As of 12/12/22, 52 IEP/evaluation meetings have been held since the start of the year. There are currently 20 initial special education referrals that have been received. The district currently has 104 students with IEPs. If all initial referrals qualify for services, this will bring the district's total students with IEPs to 124.
