# School District of Bayfield Board Report Stephanie Lewis, Director of Special Education/Pupil Services December 18, 2023

**School Counselors** Strategic Priority - Student & Staff Health and Wellbeing, Student Success

The school counseling team, including Karla Vinci, Amy Day, and Brian Boyd, joined by Mike Peterson, have worked on the following topics over the last month: • Progress - ES school counseling instruction. Classroom management a struggle with some specials. Brainstorm ideas of potentially partnering NAC and School Counseling instruction

- Is Second Step being used? Co-Teacher tends to use this Brook, Colleen, Sarah, 3rd grade. Not sure about K 2. Purpose is to be intentional about coordinating Sources of Strength content (Amy D) with Second Step (regular ed. teachers.)
- IEPs School counselors need to connect with case managers prior to meetings if they can't attend.
- Mike, Shellie, Beth requesting school counselors supervised by principals next year.
- Next Steps: Explore alternatives to the b.e.s.t. Universal Behavior Screener, explore a way to facilitate small group school counseling since guidance is out of the specials rotation, build our website Mary Maderich was going to work with Chris P.
- Amy is starting some small groups. She has also gone to the middle school classes to introduce herself and talk about how school counselors can support students.
  - Building the Heart of Successful Schools Conference Steph registered for virtual participation. With recorded access available mid-December, the pupil services team will schedule time to view selected sections of the conference.
- Stronger Connections Grant Submitted November 15. The district will be notified sometime in February if we are awarded this grant (up to \$300,000.) School webpage Create a document for ideas to share with IT. Mary M @ CESA will help with required elements on pupil services page.

- Stronger Connections Steph 300K, will hear back February 2024 Vaping prevention Karla working on vaping cessation program with students who want to quit.
- Bayfield County Holly
  - Meeting with each school's administrative team in the county to integrate substance abuse curriculum. CESA 12 instructor would be available to guest instruct in schools. County administrator could be a possible source of funding.
  - Substance Prevention Alliance looking to donate money to schools for extracurricular activity support (skiing, dances, lock-ins, etc.) It was suggested that she contact MS/HS principal, Shellie Swanson for specific initiatives.
  - Puberty starting as early as 4th grade @ BSD. Human Development and puberty talk with 5th graders - Laura from Bayfield County could come support Jackie and regular education teachers. Potentially have after school office hours once a month to support youth (at school, Beth okayed.) Include Kennedi Bernia, MS/HS PE teacher, on this
    - conversation. She is currently using FLASH curriculum for middle school and 10th grade health. The committee glanced at <u>WI State Health</u> <u>standards</u>. FLASH curriculum aligns. Much of the curriculum used by elementary school counselor, Amy D, covers elementary health standards.
  - Last year had a speaker from New Day. Jackie is looking into continue this year as well with 5th, MS, HS.
  - Kat sharing <u>Health and Human Development curriculum</u> with the committee
  - Blue Sky integrated into elementary? Bayfield Co could potentially cover costs for school employee to teach or someone in Red Cliff who is already trained.
- Flow-Through Grant able to be used for behavior/academic intervention purposes (Stephanie) → possible funding for trauma-sensitive training RC wrap around & resource coordination Diane
- USDA Farm to School Grant Kat. Stephanie is willing to assist with crafting of grant.
- Character Ed. next steps Admin, Pupil Services. Explore Circle of Courage, <a href="https://starr.org/">https://starr.org/</a>. Prepare staff by building knowledge of staff vs. all of the sudden implementation slow integration. Have staff input. Staff Wellness
  - How do we allow staff more time for prep hours/contracted time K-12. Stephanie will bring the request to explore the daily schedule at each school to identify priorities for planning and better supports for

instruction and supporting students.

- Option to hire lunch and recess monitors to give K-5 teachers time to prep?
- Middle/High School Snack
  - RC Family & Human Services Division does not have funds at this time Could it be considered an intervention? Potentially use CCEIS grant funding Stephanie to look into.

## **Special Education -** Strategic Priority - Student Success & District Excellence

- The special education department continues to work on corrective action steps as a result of the RDA:PCSA. The goal of the self-assessment is to ensure compliance with selected legal requirements and improve outcomes for students with disabilities. All compliance errors must be corrected by January 15, 2024.
- The ad hoc committee will meet on December 19, 2023, to review the assessment results.
- DPI Alternate Assessment report was submitted by Stephanie 12/12/23. Will continue to work on Needs Assessment for disproportionality report requirements.
- Elementary paraprofessionals participated in a SIPPS intervention training lead by elementary teacher, Colleen Trumper.
- As of 12/14/23, 68 IEP/evaluation meetings have been held since the start of the school year. Twelve initial special education referrals have been received. The district currently has 127 students with IEPs.
