 - Concern about unhealthy foods coming to school. Stephanie Bakker (UW-extension) work with Karen Boutin to create a one-page "Suggested Snacks" sheet to be sent home and posted on the web page.
 - Potential policy change? Restrict when/if/what foods from home can be eaten? Language to restrict food in the classroom? No snacks coming from home? Policy does have language regarding healthy foods *on campus*. Policy may simply need to be enforced.
 - Would it be easier for teachers if the school rules restricted food in the classrooms?
 - Beth, Steph, Butch, and Manzanita met 1-23-24, to discuss MS/HS stack funding. \$500-\$1000/month. Need to create a photo list of snack options from Walmart. Manzanita can come to school to do food-related demonstrations.
 - Diane felt that the Tribe can support also. Parents DO read the newsletters and there can be some parenting info. on nutrition and healthy snacks in the newsletter.
 - Snack swap...students can exchange an unhealthy snack for a healthy snack.
- Circle of Courage <u>Materials</u>
 - Michelle didn't feel that training was necessary, but duty free time (lunch duty, recess duty, subs for specials.)
 - Who is doing this in other schools?
 - Teachers lacking the emotional bandwidth. Restorative practices not being used as often as they should be. Mental health affecting physical health.
- Community service focus start with a general list of community service options and appropriate ages List Link. Holly has started an age-appropriate list for when we are ready to move on a community outreach program.

Special Education - *Strategic Priority - Student Success & District Excellence*

• The special education case managers met February 16, 2024, to discuss 2024-2025 caseload changes. Next meeting March 8, 2024, 1:30.

- With the increasing number of special education students and the severity of the behavioral needs, coverage and staffing was discussed. Elementary and middle school caseloads are at/beyond capacity. Middle school sees a "bottleneck" effect. The team considered the possibility of shifting a case manager to a grades 5 & 6 case load to alleviate the overload at the middle school level. *An additional special education teacher will be necessary at the elementary level*, regardless of how the middle school loads shift.
- Colleen and Stephanie finished entering accommodations for students with IEPs and 504 plans for the Forward Exam.
- As of 2/21/24, 125 IEP/evaluation meetings have been held since the start of the school year. Eighteen initial special education referrals have been received. The district currently has 134 students with IEPs and 11 students with 504 plans.
