Winter Transportation Committee Meeting

Special Education Aid Payment Information FY 2025 Aid Payment for RY2023-24 Expenditures

The amounts for the December 16, 2024, payment of Special Education and School-Age Parents categorical aid, the second payment of the year, have been determined. We have been notified by DPI that this year's November through March interim payments will use a proration rate of 29.16% percent. A slightly lower rate is used for these payments to avoid overpayment; the final payment in June 2025 will reflect our full aid eligibility at the year's final proration rate. We used a 31% reimbursement rate for revenue projections.
