#### Student Success:

The second evening of Parent/Teacher conferences was held at Legendary Waters conference center on November 6th. The event was well attended; we had almost forty families sign in and meet with teaching staff.

With the end of first quarter and sports in full swing, teachers are working closely with families to support our athletes to ensure they are eligible to play. All athletes must be passing all classes and attend the full day of school to be eligible to play. Grades are checked weekly. Coaches and Athletic Director check attendance on game day.

## Student & Staff Health and Wellbeing:

Super Secret Staff Spirit Week was held the full week before Fall Break. Staff had Ninja Day, Impeccable Day, An Apple a Day, Anything but a Cup Day, and Zoom Day. Lots of laughs and even more confused students all week were wondering what the heck the staff was up to. Teachers sharing input to update the High School Course Handbook for 2025-26 school year.

Calendar committee has begun meeting to develop a proposed school calendar for next year. Attendance data was shared with the committee. The data shows lower attendance when K-5 is not in school. However, special days such as final exams and Apple Fest Friday showed an increase for high school students. The committee is working with administration to look at all options, including two possible calendars (K-5 and 6-12), shorter days for K-5 with different busing schedules, four-day school week, trimesters for MS/HS, etc. These are all ideas, nothing has been finalized and plans for community survey/input is needed.
